Subject: **Peace (less crime) In Huerfano County - Part 6 (former 3/9/18)**

The last thing I left you with, Sheriff, was about **THE MOST POTENT FORCE IN THE UNIVERSE**. Think about it, with our physical actions like speaking or building structures and organizations, we can cause some degree of change in the world, and we can influence people, but with the power of mind over matter we can move mountains.
